
## Scalby School

### Travel Plan


#### Description of the school:

Scalby School is a successful and popular 11-16 community school based in picturesque seaside town of Scarborough on the North Yorkshire Coast. We currently have approximately 1000 students on roll. In recent years we have become the school of choice in our local community. Many of our staff choose to bring their own children to Scalby School from out of catchment.

The school catchment area supports both urban and rural communities. It is from villages to the north of Scarborough including Ravenscar, and along the Pickering Valley (not including West Ayton up to Ruston). It also includes an area to the east of the school, cutting through the Barrowcliff Estate and along Wreyfield Drive. The catchment's travel distance is generally within 12 miles of school, but a significant minority of students come from out of this catchment. Approximately 80% of students travel 3 miles or less.



The school is situated to the north of Scarborough in a built-up residential area on a narrow road approximately 100 metres from a busy main road and public transport (bus) links on the A171 Scalby Road.

### Travel Plan

There is a 20-mph speed limit along Fieldstead Crescent in front of the school, which is also a one-way street, and 30 mph limits on the adjoining roads – Hirstead Road, Greenstead Road, Coldyhill Lane and Green Lane. The school has two staff and visitor car-parks, catering for approximately 65 vehicles. Zig-zag and double yellow lines outside the school and its entrances prevent parking on the school side of Fieldstead Crescent but parking is allowed opposite and on the adjoining road.

ALL Drivers should always proceed slowly within the car parks and obey the 5 mile per hour speed restriction. Please bear in mind that some young people and some students with additional support needs may have little or no awareness of road safety and you should take account of this. ALL Drivers are expected to act responsibly on the site when parking and accessing the school building.

Staff and visitors should supply the school with your registration number so that you can be contacted if there is a need to do so.

#### **Bicycles**

Staff and Students cycling to school must enter the grounds via any of the pedestrian entrances. Cyclists MUST dismount their cycles at the pedestrian entry gate and walk their cycles in the cycle compound. Staff cycle compound is found in the upper staff carpark behind student toilets. Students cycle compound can be found in front of the languages block on the main playground. They should exit the school via this same route. We actively encourage students to cycle to school as it is good for their health, but they must keep themselves safe when doing so by complying with all traffic laws, being aware of other road users and wearing a cycle helmet.

#### **Students**

Students are expected to walk to the school in a safe manner, setting a good example including those arriving by cycle or scooter.

Any Student over the age of 16 wishing to ride a moped or motor bike to school must also park in the main carpark.

#### **Visitors**

Visitors are welcome to park in the school carpark if there are sufficient spaces. There are no designated visitor parking areas so visitors should park in the same areas as staff. The car parks are often busy, and visitors should only use a proper parking bay and must not park in any other areas such as footpaths or grassed areas or in front of any gates.

To access reception, is down the main driveway on the hashed areas.

Access into the school is only permitted from the main reception entrance. Visitors are required to sign in and leave a note of their registration number with staff. On departure, visitors should sign out at main reception and leave the building by the main entrance door.

#### **Servicing/ Deliveries**

The school actively discourages deliveries between 08.00-08:30am and 14:30 to 15:00pm to ensure students are out of the building and reduce the likelihood of any accidents. Site access for deliveries is from the main car park, gates will be opened by the site team on arrival and monitored

throughout delivery. Drivers should always proceed slowly down the drive and obey the 5 mile per hour speed restriction and park appropriately. The site team will always attend deliveries on the site.

**Vehicles & School Buses/Taxi Services/Parents/Carers Designated school buses/minibuses.**

All buses, taxis, and parent/carer vehicles must park and wait in the main carpark, and at all times follow the one way system.

Please be aware of students arriving/leaving the site on foot through the school top gate.

Parents/Carers are asked to refrain from parking outside the school. This prevents congestion around the school site.

**Disabled Parking**

Disabled parking is accessible via the top staff entrance carpark, clearly marked next to the oak tree.

**Supervision**

The Senior Leadership Team (SLT) should arrange for daily supervision around the bus park and the pedestrian areas at the beginning and end of each school day. High visibility waistcoats should be worn when carrying out this duty.

Any imminent issues or concerns regarding the travel plan will be addressed and reviewed by the SLT accordingly.

The objectives of this travel plan are to:

- Make journeys to and from school as safe as possible, and
- Encourage more active, sustainable modes of travel such as walking and cycling.
